8.8 agree that in the event that the Niche is surrendered prior to the expiry of the Term, there shall be no refund of any payments made.

8.9 agree that neither this agreement nor anything in it confers any rights over any part of the Site and agree to ensure that all visitors remain within the boundary of the site.

8.9.1 agree that Mid-England Barrow Ltd may transfer its rights and obligations under this agreement to a third party.

8.9.2 give consent that my niche cover may be used, anonymously, in photographs used by MEB.

9. Agreement of Mid-England Barrow Ltd
